NOTICE

In pursuance of the communication/order issued by the Principal Secretary to the Government of West Bengal (vide ref. no. 17-Pr. Secy-HED/2020 dated 30.07.2020) to combat against the spread of Novel Corona Virus (nCOVID-19), this is to inform all concerned that the restriction imposed vide earlier communications by the Government of West Bengal (ref. no. 15-Pr. Secy-HED/2020 dated 23.06.2020; 12-Pr. Secy-HED/2020 dated 30.05.2020; 86-SSE/20, dated 14.03.2020; 87-SSE/20, dated 15.03.2020 & 07-Pr. Secy-HED/2020, dated 17.03.2020) has been extended further up to 31st August, 2020 for public interest.

University and affiliated colleges (under the control of the University of Gour Banga) will remain closed up to 31st August, 2020 in view of the evolving situation on the spread of the Novel Corona virus (COVID-19) as a matter of abundant precaution to check its spread.

The examinations of the University and all the affiliated Colleges will also remain suspended up to 31st August, 2020.

Hostels will also remain closed till 31st August, 2020, though adequate arrangement as per medical protocol shall be made for foreign student (if any) who are not able to leave the campus/hostel due to distance or otherwise. No visitor should be allowed during the period to visit the hostel, without prior approval of the superintendent of the respective hostel.

However, administrative departments like office of the Principal/Head of the Institute of the affiliated colleges (under the control of the University of Gour Banga) and office of the Vice Chancellor, Registrar, Finance Officer, Controller of Examinations of the University may remain open for emergency works as and when required. The emergency services e.g. evaluation process related to examinations, electricity, cleanliness, water supply, security etc. will remain open with necessary precautionary measures.

However, as State Government has announced admission process in UG level courses, concerned teaching/non-teaching staff deployed for the purpose will remain exempted from the restrictions imposed vide earlier orders. However, COVID-19 norms/protocol shall be maintained as per government order issued from time to time.

This notice is issued with the concurrence of the Hon'ble Vice-Chancellor of the University of Gour Banga.
