Balance sheet and P&L Accounts for last two years, credential etc. at the office of the Convener, Tender and Purchase Committee mentioned above from 11 a.m. to 5 p.m.
6. Documents like PAN, GST and Trade License are to be submitted with the tender paper.
7. Validity of the quotation will be one year from the closing date of the enquiry.
8. The University of Gour Banga reserves the right to amend or cancel the scope of the work as well as to modify the terms and conditions of the tender.
9. The number of items may increase or decrease by the demand/decision of the authority of University.
10. Damage to goods or any other loss due to accident etc. during transit shall be the Responsibility of the supplier/ agency.
11. Suppliers must have credential with the specific items otherwise submitted quotation will be rejected.
12. Time of delivery shall be reckoned before 07 days from the date of receipt of work order.
13. Warranty period will be considered as provided by the Agency/ Supplier.
14. Price shall be quoted in Indian Rupees (INR) inclusive of all taxes, installation & delivery Charges.
15. Tools and tackles for any installation work as required shall have to be arranged by the agency at their own cost.
