Qualifications and Experience:

As per UGC Notification No.: F.3-1/2009, Dated: 30.06.2010, (please visit UGC website for details) notified in the Gazette of India on 18th September, 2010, UGC Notification No.: F.1-2/2016 (PS/Amendment), dated the 4th May, 2016, No.: F.1-2/2016(PS/Amendment), dated the 11th July, 2016 and relevant Memorandum of Higher Education Dept., Govt. of W.B. No.: 120 - Edn.(U)/1U-91/10, Dated: 21.02.2011; W.B. No.: 121 -Edn.(U)/1U-91/10, Dated: 21.02.2011; No.: 516-Edn(U)/1U-91/10, dated Kolkata the 16th May, 2017.

Appointments will be made on probation for one year which may be waived or extended in exceptional cases and will be guided by the rules as framed and/or amended from time to time. During or at the end of the period of probation, the service of the Teacher concerned may be terminated with one month's notice or with one month's salary in lieu thereof, without assigning any reason thereof. On satisfactory completion of the probationary period the incumbent concerned will be considered for being confirmed in service. Stipulations in respect of Experience and Age may be relaxed by the Executive Council in case of exceptionally brilliant candidates on the recommendation of the relevant Selection Committee. Candidates already in employment should apply through proper channel.

Application forms to be downloaded from the University Website www.ugb.ac.in and are required to attach a Bank Demand Draft of Rs. 2,500.00/- [Rs.1500/- for SC/ST/OBC-A/OBC-B] payable at "Malda" drawn in favour of the "University of Gour Banga" along with the filled-in prescribed forms. Application [1 (One) Set of self-attested copies of all testimonials alongwith 5 (Five) sets of Filled in Application Form and API Sheet] should reach the "OFFICE OF THE REGISTRAR, UNIVERSITY OF GOUR BANGA, P.O.: MOKDUMPUR, DIST.: MALDA, WEST BENGAL - 732103, INDIA" on or before October 1, 2018 (except Saturday, Sunday & Govt. Holidays, during 11:00 a.m. to 05:00 p.m.). The 'Name of the post along with Subject applied for and Advertisement No.' must be indicated on the envelope.

All relevant information like API (Academic Performance Indicator), etc. required in accordance with the UGC Notification No.: F.1-2/2016 (PS/Amendment), dated the 4th May, 2016, No.:F.1-2/2016 (PS/Amendment) dated the 11th July, 2016 are to be furnished on separate sheets along with supporting documents and to be attached with the application forms.

Service conditions as will be notified by orders of the higher Education Department, Govt. of West

Bengal from time to time will be applicable. Appointment process will strictly abide by the reservation policy

of the State Government.

N.B.: Candidates belonging to the OBC-A & OBC-B categories, whose caste certificates were issued

more than one year ago, must produce a ratification certificate from the issuing competent authority that they

do not belong to the creamy layer as on the date of advertisement along with copy of previous certificate to

enable this University that for the purpose of reservation including SC/ST, the certificate issued by the

competent authority within the state of West Bengal shall only be considered as valid. Such certificates issued

from other states shall not be considered for the purpose of reservation. However, such candidates from the

other states may apply as unreserved candidates.

Application received after due date and time will be rejected summarily. Incomplete applications shall

also be treated as cancelled and the University Authority shall not be liable to explain any reason in the matter.

PROFESSOR

1) Minimum Eligibility Criteria

- i) An eminent scholar with consistently good academic record and a Ph.D. degree in the concerned/ allied/ relevant discipline with a number of high quality research publications in reputed journals and / or publication of books.
- ii) At least 10 years' experience in University/ College and/ or experience in research in university/reputed research institutions/ industries.
- iii) Research guidance of doctoral students.
- iv) A minimum score as stipulated in the Academic Performance Indicator (API) based on Performance Based Appraisal System (PBAS), set out in the UGC Regulations 2016 in Appendix III Table II(B).

OR

An outstanding professional with established reputation in the relevant field, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, to be substantiated by credentials.

2) Additional Experience

- i) Contribution to educational innovation, design of new curricula and courses and use of modern technology in teaching-learning process.
- ii) Guidance of Ph. D students/ research projects.

NOTE

1: Relaxation of Marks for Direct Recruitment of Assistant Professor, Associate Professor and Professor:

- i. A relaxation of 5% may be provided at the Graduate and Masters level for the Scheduled Castes/ Scheduled Tribes/ Differently-abled (physically and visually differently-abled)/ Other Backward Classes (non-creamy layer) categories for the purpose of eligibility and for assessing good academic records during direct recruitment to teaching positions. However, differently-abled (physically and visually) candidates are not eligible for any marks relaxation in Physical Education discipline.
- ii. The minimum qualifying marks of 55% is relaxable by 5% marks (from 55% to 50%) at the Master level for Ph.D. Degree holders who have obtained their Masters degree prior to September 19, 1991.
- iii. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.
- iv. All the essential qualifications must have been obtained from a recognized University/ Institute. By a recognized University/ Institute is meant a University/ Institute affiliated to UGC/ other statutory apex bodies or recognized by the State or Central Government as a centre of higher learning. In case of a foreign University, the Degree concerned should be recognized as equivalent to its Indian counterpart by the Association of Indian Universities.

- 2. Relevant/allied disciplines in each case, good academic record may be decided by the appropriate bodies of the concerned University.
- 3. The Period of time spent by the candidates to acquire M. Phil and/ or Ph.D. degree shall not be claimed or considered as teaching/research experience for appointment to the post of Associate Professor/ Professor.
- 4. Composition of the selection committee and the selection criteria based on the candidates' academic record, research experience, performance in his/her previous academic/ research positions in the colleges/ universities/ research institutes/ industries and other related aspects may be decided by the appropriate bodies of the concerned university taking into consideration as far as practicable, the relevant guidelines of UGC in such matters.
- 5. A minimum Academic Performance Indicators (API) based on Performance Based Appraisal System (PBAS), set out in the UGC Regulations, 2016 in Appendix III Table II(B) score and weightages in Selection Committees are essential for Direct Recruitment as mentioned below for the post of Assistant Professor, Associate Professor and Professor.

- 6. The overall selection procedure shall incorporate transparent, objective and credible methodology of analysis of the merits and credentials of the applicants based on weightages given to the performance of the candidate in different relevant dimensions and his/her performance on a scoring system proforma, based on Academic Performance Indicators (API) as provided in the UGC Regulations 2016 (4th Amendment) in Tables I to XI.
- 7. In addition to the minimum eligibility criteria and experiences as stated above for each category of academic positions, the concerned universities may include other relevant qualifications/experiences.
- 8. Age Limits: Age limit for the post of Associate Professor and Professor will be followed as per the UGC Guidelines in this regard and their amendments from time to time.

General Instructions to the Candidates:

- 1. No application except in prescribed Application Form will be considered.
- 2. A person working in Govt. / Semi-Govt. / Public Sector undertaking must apply through proper channel.
- 3. Incomplete application will not be entertained.
- 4. University authority will not be responsible for any postal delay.
- 5. No TA/DA shall be paid to the candidates for attending the interview.
- 6. Application fees once paid shall not be refunded under any circumstances.
- 7. The University shall verify the antecedents or documents submitted by a candidate at any time at the time of appointment or during the tenure of his/her service. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his/her service shall be terminated.
- 8. The University reserves the right not to fill up the post advertised if the circumstances so warrant.
- 9. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
- 10. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the competent authority shall be final.
- 11. If any candidate is recommended for appointment in relaxation of any of the prescribed conditions relating to age, experience etc, it shall be so stated and recorded by the Selection Committee.
- 12. The prescribed qualifications and experience will be minimum and the mere fact that a candidate possessing the same will not entitle him for being called for interview. The University will have the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed or by any other condition that it may deem fit.
- 13. In cases of any disputes any suites or legal proceedings against the University, the jurisdiction shall be restricted to the Calcutta High Court.
