1	Each Water Purifier cum Water Cooler should comprise with A) KENT Commercial RO Water Purifier with RO+UF+TDS Control (Model no-KENT ELITE II) and B) USHA 80 Litres Water Cooler along with standard accessories (model no-SS 4080, storage capacity-80 lts.) and C) Iron Guard—20 inch. Commercial.

### **Terms & Conditions—**

- a) The following documents are required to be attached with the quotation—
  - i) Valid Trade License.

  - iv) Professional Tax certificate upto-date.
  - v) Credential certificate as mentioned below.
- b) Taxes will be deducted as per Government norms.
- c) Intending bidders should produce credentials of a similar nature of completed work/supply work of the minimum value of 30.00 % of the quoted amount during 5 (five) years prior to the date of issue of the quotation notice, or, intending bidders should produce credentials of 2 (two) similar nature of completed work/supply work, each of the minimum value of 25.00 % of the quoted amount during 5 (five) years prior to the date of issue of the quotation notice.
- d) Bidders should attach the price list of the products duly self-attested for Sl no A) & B) as mentioned in the item of supply.**
- e) Warranty and free maintenance period will be considered as per manufacturer(s) specification.
- f) The quotationer must have service infrastructure locally for rendering services after sales within 24—48 hrs from the date of receipt of complains.
- g) There will a retention of 5.00 % of bill value as security deposit which will be released after 1 (one) year and on getting successful maintenance support for the said period of time.
- h) University authority may take also administrative/legal steps against the successful bidder at their discretion if the warranty/guarantee/services are not provided properly and in time.
- i) Recommendation of payment will be done only after successful delivery and installation of the materials.
- j) Payment will be made through account payee cheque.
- k) Price shall be quoted in Indian Rupees (INR).
- l) Time of delivery shall be reckoned 14 (fourteen) days from the date of receipt of work order.**
