OFFICE ORDER

No.: 528/UGB/R-25 dated 12.12.2025), the undersigned is directed to notify the following decisions regarding the processing of Grievance Redressal for compliance by all concerned:

1. Redressal of Student and Faculty Grievances : All grievances/complaints of students and faculty members shall be addressed strictly through the prescribed hierarchical mechanism as detailed below:

Grievances/complaints should not be addressed directly to the Hon'ble Vice Chancellor.

2. Reporting of Sexual Harassment Cases: Any incident of sexual harassment occurring within the University campus shall be reported confidentially to the Registrar, who shall forthwith forward the same to the Presiding Officer of the Internal Complaints Committee (ICC) [vide Ref. No.: 019/UGB/DR-26 Date: 08.01.2026] for necessary action in accordance with applicable rules. In such cases, the aggrieved person may also contact the Presiding Officer, ICC directly. The list of ICC members shall be displayed on the departmental notice boards.

This Office Order shall come into force with immediate effect.

All the Head of Academic and Administrative Departments are requested to circulate the office order and kindly disseminate the information among all concerned.
