NOTICE

In accordance with the advisory of the Department of Higher Education, Govt. of West Bengal (*vide* Ref. No. 378-EH/1U-37/2020 Dated, 27.06.2020), the modalities of the Final Year / Terminal Semester Examinations, 2020 at the UG and PG levels adopted in the emergent meeting of the Executive Council (EC) of University of Gour Banga, Malda held on 9th July, 2020, proposed by the Examination Monitoring Committee (*vide* Ref. No.: Online Emergent EMCM-03/UGB/CE-2020, dated: 28th June, 2020) and P. G. Core Committee (*vide* Ref. No.: Online Emergent PGCM-02/PG/UGB/CE-2020, dated: 28th June, 2020), are notified for all concerned as follows:

1. FOR UNDER GRADUATE (UG) DEGREE COURSES

a. For General UG Degree Courses [UG Part-III (Honours and General) Examinations, 2020]

- The results for the final year, *i.e.* Under Graduate Part-III (Honours and General) Examinations, 2020 will be prepared on the basis of 80:20 ratio, where 80% weightage will be considered on the basis of the best aggregate percentage obtained by the candidate in any of the previous years' results (*i.e.* Part-I or Part-II Examination) and 20% weightage on Internal Assessment during the current year, irrespective of the nature and type of the subject / paper.
- The 'back' / 'supplementary' paper(s) will be cleared on the basis of average mark of the marks obtained in the remaining qualified papers of that year/semester.
- The mode and nature of the Internal Assessment will be decided by the concerned College Principal / TIC / OIC and the concerned College Principal / TIC / OIC will take responsibility for the submission of the obtained marks of the Internal Assessment of the examinees to the Office of the CoE, UGB within stipulated timeframe (as notified by the Office of the CoE, UGB).

b. For Professional UG Degree Courses (Like - B.A. LL.B., B.C.A and others) [Final Year / Semester Examinations, 2020]

- The results for the final semester of any professional under graduate courses will be prepared on the basis of 80:20 ratio, where 80% weightage will be considered on the basis of the best aggregate percentage obtained by the candidate in any of the previous semesters' results and 20% weightage on Internal Assessment during the current semester, irrespective of the nature and type of the subject /paper
- The 'back' / 'supplementary' paper(s) will be cleared on the basis of average mark of the marks obtained in the remaining qualified papers of that year/semester.
- The mode and nature of the Internal Assessment will be decided by the concerned College Principal / TIC / OIC and the concerned College Principal / TIC / OIC will take responsibility for the submission of the obtained marks of the Internal Assessment of the examinees to the Office of the CoE, UGB within stipulated timeframe (as notified by the Office of the CoE, UGB).
- As the 9th Semester Examinations for the B.A.LL.B courses are not completed yet, the same advisory for the preparation of the results of the terminal semester will be applicable for this Semester too, wherever 80% weightage will be considered on the basis of the best aggregate percentage obtained by the candidate in any of the previous semesters' results (*i.e.* Semesters I to VIII Examinations) and 20 % weightage on Internal Assessment during the current semester, irrespective of the nature and type of the course / subject / paper.

2. FOR POST GRADUATE (PG) COURSES

a. M.A. / M.Sc. / M.Com. Semester IV Examinations, 2020

- The results for the terminal semester, *i.e.* Post Graduate Semester IV Examinations, 2020 will be prepared on the basis of 80:20 ratio, where 80% weightage will be considered on the basis of the best aggregate percentage obtained by the candidate in any of the previous years' results (*i.e.* Semester I / II /III Examinations) and 20 % weightage on Internal Assessment during the current semester, irrespective of the nature and type of the course / subject / paper.
- The 'back' / 'supplementary' paper(s) will be cleared on the basis of average mark of the marks obtained in the remaining qualified papers of that year/semester.
- The mode and nature of the Internal Assessment will be decided by the concerned Department through Departmental Committee (DC) and the concerned HODs / Coordinators / TICs of the departments will take the responsibility for the submission of the obtained marks of the Internal Assessment of the eligible examinees of the PG Semester III and Semester IV Examination 2020 to the Office of the CoE, UGB within stipulated timeframe (as notified by the Office of the CoE, UGB).

b. M.A. / M.Sc. / M.Com. Semester III Examinations, 2020

- As the 3rd Semester Examinations in most of the departments are not completed yet, the same advisory for the preparation of the results of the terminal semester will be applicable for the 3rd Semester too, for the departments, where no examinations or

partial examination have been conducted yet, wherever 80% weightage will be considered on the basis of the best aggregate percentage obtained by the candidate in any of the previous semesters' results (i.e. Semester I / II Examinations) and 20 % weightage on Internal Assessment during the current semester, irrespective of the nature and type of the course / subject / paper.

- For the Departments where complete or partial 3rd Semester examinations have been conducted before the countrywide lockdown, the Results will be prepared as per the performance of students in the examination as per usual practice. The concerned HoDs / Coordinators / TICs of the departments will take responsibility for the completion of the evaluation of the answer scripts and submission of the marks of the examinees to the Office of the CoE, UGB within stipulated timeframe (as notified by the Office of the CoE, UGB).

- The 'back' / 'supplementary' paper(s) will be cleared on the basis of average mark of the marks obtained in the remaining qualified papers of that year/semester.

c. L.L.M. Semester IV Examinations, 2020

- The results for the terminal semester, i.e. Post Graduate Semester IV Examinations, 2020 of L.L.M. course will be prepared on the basis of 80:20 ratio, where 80% weightage will be considered on the basis of the best aggregate percentage obtained by the candidate in any of the previous years' results (i.e. Semester I / II / III Examinations) and 20 % weightage on Internal Assessment during the current semester, irrespective of the nature and type of the paper.

- The 'back' / 'supplementary' paper(s) will be cleared on the basis of average mark of the marks obtained in the remaining qualified papers of that year/semester.

- The mode and nature of the Internal Assessment will be decided by the concerned Department through Departmental Committee (DC) and the concerned HODs / Coordinators / TICs of the departments will take the responsibility for the submission of the obtained marks of the Internal Assessment of the eligible examinees of the PG Semester III and Semester IV Examination 2020 to the Office of the CoE, UGB within stipulated timeframe (as notified by the Office of the CoE, UGB)

d. L.L.M. Semester III Examinations, 2020

- As the 3rd Semester Examinations in departments is not completed yet (L.L.M. course), the same advisory for the preparation of the results of the terminal semester will be applicable the 3rd Semester too for the department, where 80% weightage will be considered on the basis of the best aggregate percentage obtained by the candidate in any of the previous semesters' results (i.e. Semester I / II Examinations) and 20 % weightage on Internal Assessment during the current semester, irrespective of the nature and type of the paper.

- The 'back' / 'supplementary' paper(s) will be cleared on the basis of average mark of the marks obtained in the remaining qualified papers of that year/semester.

3. The portion of the academic session 2019-2020 affected by imposition of lockdown should be treated as '100 % Class Attended' by all the students.

4. Considering the financial constraints faced by the candidates due to the COVID-19 pandemic, **Examination and Centre Fees are waved off** for Final Year / Terminal Semester Examinations only for both Undergraduate and Post Graduate Examinations. For UG Part-III (Honours & General) Examinations 2020 and B.A.LL.B. 10th Semester Examination 2020, the College authorities are requested to consider the college related fees of students sympathetically.

5. For intermediate year/semester, all students shall be promoted to the next Year/ Semester.

6. Following the advisory, it was also decided that if any student wishes to appear in a formal examination instead of alternate evaluation method, an opportunity will be offered to him/her to apply the same through a process to be notified by the University after the publication of results of the final year. However, the said special examination will be conducted only after the situation gets normalized. The final result marks would be revised as per the student's performance in the special examination, irrespective of whether he/she secures more or less marks than what is awarded to him/her through alternate evaluation method.

Eager students must have to submit an undertaking along with the original mark sheet before appearing in this special examination.
